ESHWAR SHIPPING SERVICES, AT VISAKHAPATNAM PORT.

FURTHER I (**CAPT. PARK HAE SUN**), UNDER TAKE THAT

1. THE VESSEL (M.V. PAN KRISTINE) FOR WHICH THE NOC CERTIFICATE IS TO BE ISSUED WOULD BE OPERATED IN "INTERNATIONAL TRAFFIC" AS DEFINED IN THE RELEVANT DTAA.
2. THE APPLICANT OF THE CERTIFICATE M/S. BERGE BULK SINGAPORE PTE. LTD. 12 MARINA BOULEVARD, # 24-03, MBFC TOWER 3, SINGAPORE 018982 . IS THE FREIGHT BENEFICIARY.
3. THE EFFECTIVE MANAGEMENT AND CONTROL OF ENTERPRISE IS SITUATED IN A COUNTRY WITH WHICH INDIA HAS ENTERED INTO A DTAA
4. THE AMOUNT OF THE FREIGHT,DEMURRAGE CHARGES, HANDLING CHARGES & ALL OTHER CHARGEABLE AMOUNT SHALL BE INCLUDED IN THE INCOME TAX RETURN TO BE FILED U/S. 172 (3) WITHIN 30 DAYS OF THE DEPARTURE OF THE SHIP.

THEREFORE, I **CAPT PARK HAE SUN**, AUTHORISE M/S. ESHWAR SHIPPING SERVICES, VISAKHAPATNAM FOR SUBMITTING RELEVANT DOCUMENTS SUCH AS BILL OF LADING, CHARTER PARTY/FIXTURE NOTE, INCOME TAX RETURNS ETC., AND PAY THE TAXES PAYABLE IF ANY ON OWNERS BEHALF IN CONNCTION WITH THE SHIPMENT OF ABOVE SAID CARGO AS PER SECTION 172 (SUB SECTION 3) OF INCOME TAX ACT NO.43 OF 1961 AS YOUR GOODSELF WILL APPRECIATE THAT I WILL NOT BE IN A POSITION TO SUBMIT THE SAME PRIOR TO THE DEPARTURE OF MY VESSEL FROM THIS PORT.
